Footsteps Foundation Grant Application

You can apply for an annual grant of between 10% – 90% (2025 cap), if your income is £90,000 (2025 cap) or less. This will be calculated on a means tested, sliding scale. If you are successful in your grant application, the grant percentage awarded will be attributed to each session you book at The Footsteps Centre in the calendar year 2025. You may also receive a further % uplift capped at the maximum grant of 90% on your 3rd and subsequent sessions attended. Please read the full Terms & Conditions attached before completing this application.

To apply:

- Your child must have had an assessment at Footsteps Centre and you must be intending to book sessions in 2025. You can apply at any time but at least 2 months before a session booking at a minimum (exception for new clients booking last minute)
- You must complete ALL sections of the application form, putting n/a if it is not applicable to you

You **MUST** include:

- Two months bank statements for ALL household bank accounts.
- Proof of all your income – 2 months' payslips, P60 or tax return for each earner
- Proof of additional income – Savings, investments and fundraising etc.
- Proof of all benefits – they must be clearly shown on bank statements or confirmation letter.

PLEASE HIGHLIGHT ALL INCOME INCLUDING BENEFITS ON YOUR BANK STATEMENTS WHEN SENDING IN.

Please note that Footsteps Foundation is a charity and is not part of The Footsteps Centre/Footsteps Ltd. The Foundation has to raise £200,000 annually from charitable trusts, community groups, companies and individuals, in-order-to be able award grants to help families access the Footsteps therapy.

The Foundation also (*2025 cap, subject to available funds):

- Have a **Helping Hand Fund** – you can apply for additional help with EITHER accommodation (current cap £900* per application) OR fuel costs (current cap £200* per application) - a new application form is required for each separate session booking or month, if weekly, forms available on the website or from claire@footstepsfoundation.com.
- Offer financial support (if no current stock) of £55* towards a **1 pair of 'Memo' shoes** annually.

Please ensure that you complete **all** sections as accurately as possible and notify us immediately should your financial circumstances change during the funding year. Footsteps Foundation reserves the right to remove grants already awarded if financial circumstances change and/or it is found out that the information provided on this grant form is in any way inaccurate.

All information provided is strictly confidential and will only be used in order to assist the Trustees of Footsteps Foundation to make a decision on any grant awarded. The information you provide to us will be kept on file and considered in the event of future applications.

The Trustees do review the thresholds and criteria for awarding grants from time to time - this may mean that even if you have received a grant before you may receive a different grant in future.

- Applications for a grant can only be made following a Footsteps assessment, and acceptance if the applicant onto the Footstep's programme. Families can apply for a grant as soon as the applicant has been accepted onto the programme, providing you intend to book sessions in 2025.

- With the exception of last minute bookings, all grant applications should be received at least two months prior to your first booked session of the year.
- Applications must be accompanied by proof of:
 - income, savings accounts, investments, fundraising, tax credits and other benefits
 - two-months' pay slips and/or P60 or tax return from all adult earners in your household
 - copies of two months' bank statements covering ALL main accounts for your household

All posted copies of documents will be destroyed and not sent back - do not post originals

- All income coming into the family home must be declared. Please do not withhold information. If we discover this has happened your grant will be withdrawn and applications will not be considered in future.
- Please **highlight** all your different income streams on your bank statement
- In the event that incomplete, inaccurate or misleading information is provided and a grant has already been awarded Footsteps Foundation reserves the right to retract any grant that has already been awarded and/or reclaim that grant from you.
- Applications are considered on an individual basis and family situations are taken into consideration.

You are welcome to include a covering note with your application if you feel it could help our Trustees to make a decision.

- Grants will be awarded according to need. Therefore, the amount of money awarded will be a percentage of the full cost of therapy. If your gross household income exceeds £90,000 (including benefits), it is unlikely that we will be able to help. An application does not guarantee that funds will be awarded.
- Your personal grant award is strictly confidential and should not be discussed with other families.
- If you are awarded a grant by the Trustees of Footsteps Foundation, that grant will be applied to **every** session you have booked within that calendar year and will be paid directly to Footsteps Limited upon completion of each session.
- If you cancel a session once a grant is awarded you will forfeit that session's grant. The grant will still apply to all other sessions booked in that calendar year. Any deposit paid will be credited to future bookings.
- If therapy hours are refunded to you by Footsteps Limited, due to child or staff sickness, you will receive a refund minus the percentage of the grant awarded.
- In order to raise funds for our family grants project, we often have to provide family feedback to our benefactors. Therefore, as a condition of receiving a grant, you are expected to provide us with feedback in the form of a case study and an online survey.
